Responses for **TRANSIT STOP IMPROVEMENTS FOR LAST MILE – IFB 2024-004, (FPID No. FM 441640-1-58-01)**, must be submitted via INFOR on or before the deadline of **2:00 p.m., Tuesday, April 30, 2024**. Verbal, hand-delivered, e-mailed, or late responses **will not** be accepted.

Prospective bidders must register with Infor, free-of-charge, in order to download the solicitation. Bidders must be pre-qualified by the Florida Department of Transportation (FDOT) in the major work class of road, bridge, or public transportation construction to respond to this solicitation. Pre-qualified certified minority business enterprises (as defined in Florida Statutes §287.0943 and §288.703) and other minority or woman-owned enterprises are encouraged to respond to this solicitation.

Disadvantage Business Enterprise (DBE) is not a requirement of this solicitation however it is encouraged.
