**OF PROPOSED ORDINANCE OF THE  
CITY OF NORTH MIAMI**

NOTICE IS HEREBY GIVEN that the City of North Miami, Florida proposes to adopt the following Ordinance:

- (1) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING THE OFFICIAL 2036 FUTURE LAND USE MAP TO EXTEND THE BOUNDARY OF THE PLANNED CORRIDOR DEVELOPMENT (PCD) OVERLAY DISTRICT SOUTHWARD OVER THREE (3) PARCELS OF REAL PROPERTIES LOCATED AT 12290 NE 6TH AVENUE, 12280 NE 6TH AVENUE, AND 540 NE 123RD STREET WITH MIAMI-DADE COUNTY FOLIO NUMBERS 06-2230-031-0020, 06- 2230-31-0030, AND 06-2230-031-0010 TOTALING APPROXIMATELY 0.68- ACRES, IN ACCORDANCE WITH SECTION 163.3184, SECTION 163.3187, SECTION 166.041(3)(C), FLORIDA STATUTES (2023); AND ARTICLE 3, ENTITLED "DEVELOPMENT REVIEW", DIVISION 3, SECTION 3-302, SECTIONS 3-1104 THROUGH 3-1107, SECTION 3-1109, AND SECTION 3- 1110, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES, CHAPTER 29, ENTITLED "LAND DEVELOPMENT REGULATIONS".
- (2) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, PROVIDING FOR TEXT AMENDMENTS TO CHAPTER 29 OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES ENTITLED "LAND DEVELOPMENT REGULATIONS" BY AMENDING ARTICLE 4, "ZONING DISTRICTS" AND THE OFFICIAL ZONING MAP TO EXTEND THE BOUNDARY OF THE PLANNED CORRIDOR DEVELOPMENT OVERLAY DISTRICT OVER THE REAL PROPERTIES OF 12290 NE 6TH AVENUE, 12280 NE 6TH AVENUE, AND 540 NE 123RD STREET, IDENTIFIED WITH MIAMI-DADE COUNTY FOLIO NUMBERS 06-2230- 031-0020, 06-2230-031-0030, AND 06-2230-031-0010 TOTALING APPROXIMATELY 0.68 ACRES; IN ACCORDANCE WITH SECTION 166.041(3) (C), FLORIDA STATUTES (2023) AND SECTIONS 3-1002, 3-1003, 3-1005 THROUGH 3-1007 AND SECTION 3-302 OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES, CHAPTER 29, ENTITLED "LAND DEVELOPMENT REGULATIONS"; DECLARING THIS ZONING MAP AMENDMENT TO BE CONSISTENT WITH THE CITY COMPREHENSIVE PLAN; FURTHER AUTHORIZING THE CITY MANAGER TO DO ALL THINGS NECESSARY TO EFFECTUATE THE ZONING MAP AMENDMENT; PROVIDING FOR REPEAL, CONFLICTS, SEVERABILITY, CODIFICATION, AND FOR AN EFFECTIVE DATE.
- (3) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING CHAPTER 5 OF THE CODE OF ORDINANCES ENTITLED, "BUILDING STANDARDS AND REGULATIONS", AT SECTION 5-2 ENTITLED "DEFINITIONS", SECTION 14 ENTITLED "MINIMUM HOUSING INSPECTIONS", AND AT SECTION 5-36 ENTITLED "CONSTRUCTION SITE MAINTENANCE" TO REFLECT ORGANIZATIONAL CHANGES AND TO PROVIDE STANDARDS FOR MAINTENANCE OF CONSTRUCTION SITES; PROVIDING FOR CONFLICT AND SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.
- (4) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING CHAPTER 8.5 OF THE NORTH MIAMI CODE OF ORDINANCES ENTITLED "FLOOD DAMAGE PREVENTION ORDINANCE", BY AMENDING ARTICLE I ENTITLED "ADMINISTRATION", SPECIFICALLY AT SECTION 8.5-3 ENTITLED "DUTIES AND POWERS OF THE FLOODPLAIN ADMINISTRATOR", TO AMEND THE DESIGNATION OF THE FLOODPLAIN ADMINISTRATOR; PROVIDING FOR REPEAL, CONFLICTS, SEVERABILITY, CODIFICATION AND FOR AN EFFECTIVE DATE.
- (5) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING CHAPTER 13 OF THE CITY CODE OF ORDINANCES, ENTITLED "OFFENSES", BY ADDING ARTICLE VI, ENTITLED "SCHOOL ZONE SPEED INFRACTIONS"; ADOPTING FINDINGS; PROVIDING FOR USE OF TRAFFIC INFRACTION DETECTORS IN ACCORDANCE WITH STATE LAW; PROVIDING FOR A LOCAL HEARING OFFICER; REPEALING INCONSISTENT ORDINANCES; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

Public Hearings for the above Ordinances **will be held before the North Miami City Council on Tuesday, March 26, 2024, at 7:00 p.m., and Tuesday, April 9, 2024, at 7:00 pm.** in the Council Chambers of North Miami City Hall, 2nd Floor, 776 N.E. 125th Street, North Miami, Florida 33161.

Members of the public are invited to attend the Council Meeting and provide oral or written comments on the matter. Comments must be received by 10 a.m. the day of the Council Meeting in order to be read into the record during the hearing. Comments received after the deadline will become part of the record but will not be read during the hearing.
