AN ORDINANCE OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING AND ADOPTING THE BUDGET FOR THE TOWN OF MIAMI LAKES FOR FISCAL YEAR 2024-2025; PROVIDING FOR EXPENDITURE OF FUNDS; PROVIDING FOR AMEND-MENTS; PROVIDING FOR CARRYOVER OF FUNDS; PROVIDING FOR THE INCOR-PORATION OF THE ADOPTED CAPITAL BUDGET AS THE CAPITAL IMPROVEMENT ELEMENT OF THE COMPREHENSIVE PLAN; PROVIDING FOR CONFLICTS; PRO-VIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

(2) Call in live during the meeting to listen to the meeting via phone and/or to participate in public comments. If you wish to speak, please raise your hand by **pressing \*9**. This will show the Raise Hand icon on the screen and IT will allow each participant to speak one at a time as the Raise Hand icon appears.
